## Council re-affirms support for Waterway

Milton Keynes Council has unanimously re-confirmed its continuing commitment and support for the Bedford to Milton Keynes Waterway.

All three political parties were involved in wording the final motion which stressed the importance of the Bedford to Milton Keynes Waterway project to the continuing development of the City and the surrounding region.

The motion was proposed by Cllr Brian White, seconded by Cllr Janet Irons (Labour) with an amendment proposed by Cllr Chris Williams (Lib Dem) seconded by Cllr Andrew Geary (Conservative) and passed unanimously by Milton Keynes Council on 13 November 2007.

Jane Wolfson, Chair of the B&MK Waterway Trust says: "We are delighted that the council is continuing to support the waterway. The scheme has moved forward so much during the past eighteen months with the £250,000 lottery grant which has enabled us to undertake the detailed planning required prior to construction of the Milton Keynes Waterway part of the project."

Speaking in support of the motion Cllr. Brian White on behalf of the Labour Councillors said: "*This project is too important for Milton Keynes for this setback to allow it to fail. It is vital for the area that the Bedford to Milton Keynes Waterway continues to be supported.*"

Lib. Dem. Cabinet Member Cllr. Chris Williams commended the 'infectious enthusiasm' of all the advocates of the project.

The motion as amended reads
